The partnership and contemplated sale will expand Fiducial's security offer in France, which will include 9,500 skilled security professionals with end-to-end technology solutions deployed from proprietary control centers across thousands of clients' sites.

The contemplated sale is expected to close in the third quarter of 2020, subject to consultation of the relevant staff representative bodies and customary regulatory approvals.
